Finally, I understand this is only a transfer of property which conveys only certain rights under the applicable local land division ordinance, the Crockery Township Zoning Ordinance and the Michigan Land Division Act (formerly the Subdivision Control Act), P.A. 288 of 1967, as amended and does not include any representation of conveyance of rights in any other statue, building code, zoning ordinance, deed restriction or other property rights. Even if this Land Transfer is approved, I understand zoning, local ordinances and State Acts change from time to time, and if changed the resulting parcels made here must comply with the new requirements.

Finally, I understand that approval of this Land Transfer does not indicate conformance with the Crockery Township Zoning Ordinance and that the Township or any Township official cannot be held liable for failure to grant a building permit.

I understand and agree that any resulting parcel shall not be considered a building site unless the parcel conforms to the requirements of the Land Division Act or the requirements of an applicable local ordinance and is not a division of land.
