Agenda Item 1. Call to Order - Roll Call

Vice Chairman Ryan Arends called the September 18, 2012, Regular Planning Commission Meeting to order at 7:28 P.M. Roll call was taken with Commissioners Dave Meekhof, Ryan Arends, Nancy Schindlbeck and Mike Munch present. Commissioners Jon Overway, Bill Sanders and Rich Suchecki were absent. Z/A Robert Toland was also present for this session.

Agenda Item 2. Approval of the Agenda

Agenda Item 3. Approval of Minutes

The Commission reviewed the minutes from the August 21, 2012, Regular Planning Commission Meeting. Commissioner Nancy Schindlbeck made a motion to accept the minutes as written. Commissioner Mike Munch offered a 2nd. The motion was unanimously approved.

Item 5. Communications

The Commissioners received a first draft of the newly updated Comprehensive Plan to be reviewed and edited.

Z/A Robert Toland informed the Commission that Doug Stalsonburg of Exxel Engineering, Inc. representing David Ducham of Autopro, Inc. (see Aug. 21, 2012 Planning Commission minutes), made an appeal for a variance to the ZBA and may be present for the September 25th Planning Commission work session with an alternative proposal.

Agenda Item 6. Public Comment

Ms. Joanne Brownlee, of 17290 Woodland Lane addressed the Commission, inquiring why after the Township accommodated her request to rezone parcel #70-04-20-100-00, located at 16754 136th Avenue, from R-1 to C-1 (see Planning Commission Sept. 30, 2011 minutes), the Township Ordinance concerning property improvement and change of use needed to be complied with. The Commission attempted to explain that rezoning and ordinance compliance are two separate issues.

Agenda Item 7. Action Items

A. Public Hearing – John and Amber Flynn, Special Land Use, Residential Pond

John and Amber Flynn of 6289 Heights Ravenna Rd. has submitted a Special Land Use application to expand, deepen and improve a pond on parcel #70-04-10-400-004, currently vacant and zoned AG-2 Rural Agricultural Preservation, located at 11701 State Rd. Documents provided to the Commission for review included; (1) A memo from Z/A Mr.Toland to the Commission dated September 18, 2012, providing a brief description and comments. (2) An Ottawa County GIS map depicting the property and surrounding area with a print date of August 7, 2012. (3) A Crockery Township Zoning Application Form dated February 1, 2011. (4) A notice of authorization from the Michigan Department of Natural Resources and Environment (DNRE), permit number 10-70-0084-P, issued on Dec. 10, 2010 and expiring on Dec. 10, 2015; which included sketches of the proposed pond along with a dock and boardwalk.

Vice Chairman Ryan Arends opened the Public Hearing.

Mr. Toland provided a lead-in to the request and stated that Prein and Newhof (Township Engineer) did not review this plan, nor needed to, because the DEQ (former DNRE) will be doing the final inspection.

Vice Chairman Ryan Arends opened public comment.

George Langlois of 11368 States Rd. (neighbor) expressed approval of the pond proposal.

Amber Flynn (applicant) informed the Commission that she/they recently gained a Soil Erosion and Sedimentation permit from the Ottawa County Drain office, and submitted a copy to the Commission.

Vice Chairman Ryan Arends closed public comment.

It was agreed that with DEQ involvement, the escrow submitted with the application would suffice as a performance bond. The Commission found the proposal to be straightforward and could not find any conflict with the Township Ordinance. Commissioner Dave Meekhof made a motion to approve the requested Special Land Use permit for the expansion and improvement, in accordance with the DNRE, of a residential pond located at 11701 State Road, parcel #70-04-10-400-004. Commissioner Mike Munch offered a 2nd. The motion was unanimously approved.

B. Turnstone LLC. (Doug Meekhof) – Site Plan Amendment

Mr. Doug Meekhof was not present. It is assumed he would prefer to present and explain his proposal. The item was left tabled.

Mr. Dave Ducham of Auto Pro Sales/Service was present. Mr. Ducham has recently appeared before the Planning Commission and the Township's ZBA regarding a site plan review and a dimensional variance request regarding the display of automobiles for sale within the 110 foot set-back. Mr. Ducham's business is located along M-104 and is affected by the Overlay set-back provisions. Essentially, Mr. Ducham has sought to utilize a paved area within the setback, originally approved as an (allowable) access drive, for display of motor vehicles for sale. The Planning Commission has advised Mr. Ducham this would be contrary to the M-104 Overlay District ordinance provisions, which was subsequently affirmed by the Township's ZBA.

Mr. Ducham is now asking for the Planning Commission to consider an amendment to the M-104 Overlay District Ordinance that would allow him to park vehicle for sale within the 110 foot

set-back. Mr. Ducham indicated he does not wish to make other improvements to his property until this matter is considered and prefers and expedited answer.

The Commission indicated its willingness to look at options, however, Mr. Ducham was advised this was a complicated request, and would have to be considered according to required, normal procedures and that no "quick fix", if any, was in the offering.
